ORDER

Brief Facts of the Case

During the spot hearing at SDO-I Office of Rajgangpur Electrical Sub-division camp on dt.08.01.2025, the complainant appeared before the Forum whereas SDO-I, RED, Rajgangpur appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is an LT-GP consumer having connected load of 0.5 KW. That the Complainant has raised objection for abnormal DPS charged in billing during May'2024. He requested revision of bills and mentions about verbal complaints being made to the respondent earlier on.

Gist of Arguments made by the Parties

Both parties were present in the hearing. The contentions made by the parties are as follows:

Submission of the Complainant:

- The complainant submitted that wrong DPS charged in bill during May'2024 due to which high billings have been done resulted to accumulation of arrears.
- He further submitted that he had made verbal complaint to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

Reply Submission of the Respondent:

- The respondent produced the following documents:
 - Billing abstract from Mar'2021 to Nov'2024.
 - Physical Verification Report on dt.08.01.2025.
 - Written version on dt.08.01.2025.
- The respondent also agreed to the wrong DPS charged in May'2024 bill and revision of bills.
- However, the respondent requested the Forum to take appropriate decisions as necessary.

Findings of the Forum

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- From Sep'2021 to Mar'2023, provisional bills have been served at a time for 2178 units in 19 months as the meter is defective.
- Above is considered for calculation of ASD and DPS on ASD is charged for Rs.3,321.23 which is wrong and must be withdrawn.
- Therefore, it is decided by the Forum to withdraw the DPS on ASD in bills.

Directions of the forum

In view of the above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations 53 of the Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.

• The wrong DPS on ASD charged during May'2024 is to be withdrawn.

The matter is closed herewith.
