ORDER

Brief Facts of the Case

During the spot hearing at Kalunga, Electrical Sub-division camp on dt.07.03.2025, the complainant appeared before the Forum whereas SDO Electrical, RED, Rajgangpur appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is an LT-Dom consumer having no-8132-1101-2308 with connected load of 0.50 KW. That the Complainant has raised objection for Suppress billing in Oct'2023. He requested revision of bills and mentions about verbal complaints being made to the respondent earlier on.

Gist of Arguments made by the Parties

Both parties were present in the hearing. The contentions made by the parties are as follows:

Submission of the Complainant:

- The complainant submitted that abnormal billing during Oct'2023 due to which high billings have been done resulted to accumulation of arrears.
- He further submitted that he had made verbal complaint to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

Reply Submission of the Respondent:

- The respondent produced the following documents:
 - Billing abstract from Feb'2020 to Jan'2025.
 - Physical Verification Report on dt.07.03.2025.
 - Written version on dt. 07.03.2025.
- The respondent also agreed to abnormal billing during the Oct'2023.
- However, the respondent requested the Forum to take appropriate decisions as necessary.

Findings of the Forum

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- During Nov'2023 bills have been served 2169 units a month as the meter has suppressed units.
- A new meter bearing Sl. No. LW418689 had been installed on dt. 15.12.2024 and the current reading is "2169" Kwh as on dt. 07.03.2025.
- Therefore, it is decided by the Forum to revise the average bills.

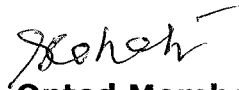
Directions of the forum

In view of the above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations 155 and 157 of the Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.

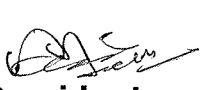
- The bills served from Feb'2022 to Oct'2023 are to be revised by taking IMR"4499" (CMR of 01/2022) and FMR as "7919" (CMR of 11/2023).
- Any adjustments made during the revision period are also to be taken into consideration.
- DPS charged on the wrong bills are also to be withdrawn.
- The complainant must clear all dues upon revision of bills.

The matter is closed herewith.
