ORDER

Brief Facts of the Case

During the spot hearing at SDO-Rajgangpur Office of Rajgangpur Electrical Sub-division camp on dt.21.03.2025, the complainant appeared before the Forum whereas SDO-Rajgangpur-II, RED, Rajgangpur appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is an LT-General Purpose consumer having connected load of 2 KW. That the Complainant has raised objection for provisional billing from Jan'2018 to Jun'2019. He requested revision of bills and mentions about verbal complaints being made to the Respondent earlier on.

Gist of Arguments made by the Parties

Both parties were present in the hearing. The contentions made by the parties are as follows:

Submission of the Complainant:

- The complainant submitted that provisional bills have been generated from Jan'2018 to Jun'2019 due to which high billings have been made resulting to accumulation of arrears.
- He further submitted that he had made verbal complaint to the Respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

Reply Submission of the Respondent:

- The Respondent produced the following documents:
 - Billing abstract from Jan'2015 to Aug'2021.
 - Physical Verification Report on dt.14.03.2025.
 - Written version on dt. 21.03.2025.
- The Respondent also agreed to the provisional billing from Jan'2018 to Jun'2019 and revision of bills.
- However, the Respondent requested the Forum to take appropriate decisions as necessary.

Findings of the Forum

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:


- From Jan'2018 to Jun'2019, provisional bills have been served with various units per month though the meter is running correctly.
- The respondent is directed to recast the case suitably at their end.
- The meter bearing Sl. No.344335 had been installed since long and the current reading is 11969 Kwh as on dt.14.03.2025.
- Therefore, it is decided by the Forum to reject the case.


Directions of the forum
