ORDER

Brief Facts of the Case

During the spot hearing at SDO-Rajgangpur Office of Rajgangpur Electrical Sub-division camp on dt.21.03.2025, the complainant appeared before the Forum whereas SDO-Rajgangpur-II, RED, Rajgangpur appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is an LT-Domestic consumer having connected load of 1 KW. That the Complainant has raised objection for abnormal billing during Oct-Nov'2024. He requested revision of bills and mentions about verbal complaints being made to the Respondent earlier on.

Gist of Arguments made by the Parties

Both parties were present in the hearing. The contentions made by the parties are as follows:

Submission of the Complainant:

- The complainant submitted that provisional/average bills have been generated during Oct-Nov'2024 due to which high billings have been made resulting to accumulation of arrears.
- He further submitted that he had made verbal complaint to the Respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

Reply Submission of the Respondent:

- The Respondent produced the following documents:
 - Billing abstract from Aug'2016 to Feb'2025.
 - Physical Verification Report on dt.20.03.2025.
 - Written version on dt. 21.03.2025.
- The Respondent also agreed to the provisional/average billing during Oct-Nov'2024 and revision of bills.
- However, the Respondent requested the Forum to take appropriate decisions as necessary.

Findings of the Forum

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- During Oct-Nov'2024, billing had been done for 11880 units at a time for 39 months which the respondent claims suppress units.
- The meter bearing Sl. No. WUS11609 had been installed during Sep'2016 and the current reading is 14926 Kwh as on dt.20.03.2025.
- The respondent is directed to recast the case by taking suitable meter reading from Mar'2019 to Nov'2024.
- Therefore, it is decided by the Forum to reject the case.


Directions of the forum

In view of the above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations 155 and 157 of the Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.

- The case is dropped off.

The matter is closed herewith.
