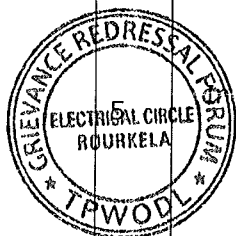

## **ORDER**

### **Brief Facts of the Case**

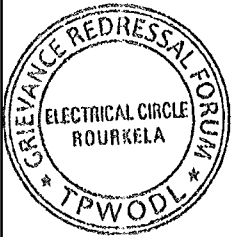
During the spot hearing at SDO-Kalunga Office of Rajgangpur Electrical Sub-division camp on dt.14.07.2025, the complainant appeared before the Forum whereas SDO-Kalunga, RED, Rajgangpur appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is an LT-Domestic consumer having connected load of 1 KW. That the Complainant has raised objection for abnormal billing during Apr'2025. He requested revision of bills and mentions about verbal complaints being made to the respondent earlier on.

### **Gist of Arguments made by the Parties**

Both parties were present in the hearing. The contentions made by the parties are as follows:


#### **Submission of the Complainant:**





- The complainant submitted that abnormal bills have been generated during Apr'2025 due to which high billings have been done resulted to accumulation of arrears.
- He further submitted that he had made verbal complaint to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

#### **Reply Submission of the Respondent:**

- The respondent produced the following documents:
  - Billing abstract from Feb'2019 to May'2025.
  - Physical Verification Report on dt.01.06.2025.
  - Written version on dt.14.07.2025.
- The respondent also agreed to the abnormal billing during Apr'2025 and revision of bills.
- However, the respondent requested the Forum to take appropriate decisions as necessary.

## **Findings of the Forum**

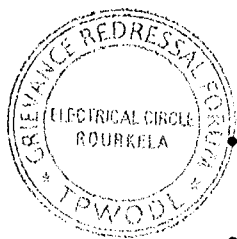
Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- During Apr'2025, an abnormal bill of 1177 units had been served which is suppressed units.
- A new meter bearing Sl. No.01139751 had been installed since long and the current reading is 19579 Kwh as on dt.01.06.2025.
- Therefore, it is decided by the Forum to recast the bills.

## **Directions of the forum**

In view of the above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations 155 and 157 of the Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.

- The average bills served from May'2023 to Apr'2025 (Two Years) are to be revised by taking IMR as "15039" (CMR of Apr'2025) and FMR as "19594" (CMR of Apr'2025).
- Any adjustments made during the revision period are also to be taken into consideration.
- DPS charged on the wrong bills are also to be withdrawn.
- The complainant must clear all dues upon revision of bills.



The matter is closed herewith.
