ORDER

Brief Facts of the Case

During the spot hearing at Bonai Electrical Section of Rourkela Sadar Electrical Division camp on dt.26.07.2024, the complainant appeared before the Forum whereas SDO-Bonai, RSED appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT-Domestic consumer with connected load of 0.50 KW. That the Complainant has raised objection regarding the high consumption bill for the month of May'2021 and provisional and average bills served to him. He requested revision of bills and mentions about verbal complaint being made to the respondent earlier on.

Gist of Arguments made by the Parties

Both parties were present in the hearing. The contentions made by the parties are as follows:

1. Submission of the Complainant:

- The complainant submitted that high consumption bill for the month of May'2021 and provisional and average bills served to him resulted to accumulation of arrear.
- He further submitted that he had made verbal complain to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

2. Reply Submission of the Respondent:

- The respondent had produced the billing abstract from Dec'2013 to Jun'2024 and a PVR dated 24-07-2024 mentioning the meter reading as "2319" of meter no. TW02068812.
- The respondent also agreed to the high consumption bill for the month of May'2021 and provisional/average/wrong billing up to Jul'2022 and also agreed for revision of bills. However, the respondent requested the Forum to take appropriate decision as necessary.

Findings of the Forum

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- As per PVR submitted by respondent, a new meter bearing Sl. No. TW02068812 had been installed on dt.16.12.2023 in the premises of the complainant.
- From Jan-2024 to Jun-2024, bills had been served with very high and low units billing on actual basis. As there is no such scope for revision, it is decided by the Forum to give slab benefits to the consumer.

Directions of the forum

In view of the above findings and discussions, the Forum is of the view that,

- The actual bills served to the complainant from Jan'2024 to Jun'2024 are to be revised by taking IMR as '118' and FMR '2248' as per Section 157 of Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.
- Any adjustments done during the revision period are also to be taken into consideration.
- DPS charged on the wrong bills are also to be withdrawn.

Matter is closed herewith and the compliance report to be submitted to the undersigned on or before dated **30-09-2024**.

"If the complainant is aggrieved with this order or non-implementation of the order of the Grievance Redressal Forum in time, he/she can make the representation to the Ombudsman-II, Qrs. No. 3R-2(S), GRIDCO Colony, P.O: Bhoinagar, Bhubaneswar-751022 within 30 days from the date of order of the Grievances Redressal Forums".
