ORDER

Brief Facts of the Case

The present case has been registered in this forum vide Case No. 444 of 2024. Brief facts pertaining to the case are that the Complainant is a LT-Domestic consumer having consumer No. 813312021253 with connected load of 1 Kw.

That the Complainant has raised objection regarding penalty withdrawal. He requested a waiver of penalty and mentions about verbal complaint being made to the respondent earlier on.

Gist of Arguments made by the Parties

Both parties were present in the hearing. The contentions made by the parties are as follows:

Submission of the Complainant:

- The complainant submitted that wrong penalty imposed upon him which must be withdrawn.
- He further submitted that he had made verbal complaint to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

Reply Submission of the Respondent:

- The respondent produced the billing abstract from Feb'2014 to Jun'2024 and a PVR dated 09-08-2024 mentioning LD in status of meter TWSP51039736.
- The respondent informed us that there was an assessment under Section
 126 of the Electricity Act, 2003 and no other dispute.
- However, the respondent requested the Forum to take appropriate decisions as necessary.

Findings of the Forum

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- This is a provisional assessment under Section 126 read with Section 135 of the Electricity Act, 2003 for unauthorized use of electricity rad with Regulation 161 of the Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.
- As the case had been received through the post, the case has been registered.
- Therefore, it is decided by the Forum to reject the case as it is not maintainable.

Directions of the forum

In view of the above findings and discussions, the Forum is of the view that,

• The case is dropped.

The matter is closed herewith.
