ORDER

Brief Facts of the Case

During the spot hearing at Kuarmunda Electrical Sub-division camp on dt.09.08.2024, the complainant appeared before the Forum whereas SDO Electrical, Kuarmunda appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT-Domestic consumer having consumer No. 8133-1306-1299 with connected load of 0.11 Kw. That the Complainant has raised objection regarding "high amount of bill was generated in the month of 04/2022 and provisional bills" served to him. He requested revision of bills and mentions about verbal complaint being made to the respondent earlier on.

Gist of Arguments made by the Parties

Both parties were present in the hearing. The contentions made by the parties are as follows:

Submission of the Complainant:

- The complainant submitted that high amount of bill was generated in the month of 04/2022 and provisional bills have been served to him due to which high billings have been done resulted to accumulation of arrear.
- He further submitted that he had made verbal complain to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

Reply Submission of the Respondent:

- The respondent produced the billing abstract from Dec'2017 to Jun'2024 and a PVR dt.12.06.2024 mentioning the meter reading as 1268 Kwh of meter no. TWSP51044526.
- The respondent also agreed to the provisional billing from Apr'2022 to Jul'2023 and agreed for revision of bills. However, the respondent requested the Forum to take appropriate decision as necessary.

Findings of the Forum

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- That the complainant has been billed on actual basis during Apr'2022 for 3579 units which is erratic as the meter is defective. After that, provisional bills had been served upto Jul'2023.
- A new meter bearing SI. No. TWSP51044526 has been installed on dt.31.08.2023 in the premises of the complainant.
- Therefore, it is decided by the Forum to revise the bills.

Directions of the forum

In view of the above findings and discussions, the Forum is of the view that,

- The bills served to the complainant from Apr'2022 to Jul'2023 are to be revised as per the average of six consecutive billing of new meter as per Section 155 and 157 of Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.
- Any adjustments done during the revision period are also to be taken into consideration.
- DPS charged on the wrong bills are also to be withdrawn.

Matter is closed herewith and the compliance report to be submitted to the undersigned on or before **dt.30.09.2024**.

"If the complainant is aggrieved with this order or non-implementation of the order of the Grievance Redressal Forum in time, he/she can make the representation to the Ombudsman-II, Qrs. No. 3R-2(S), GRIDCO Colony, P.O: Bhoinagar, Bhubaneswar-751022 within 30 days from the date of order of the Grievances Redressal Forums".
