# **ORDER**

## **Brief Facts of the Case**

During the spot hearing at Sundargarh Electrical Section of Sundargarh Electrical Division camp on dt.14.08.2024, the complainant appeared before the Forum whereas SDO, Sundargarh, SED appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT-General Purpose consumer with connected load of 05 Kw. That the Complainant has raised objection regarding wrong billing from Aug'2019 to Jul'2024. He requested for revision of bills and mentions about verbal complaint being made to the respondent earlier.

## **Gist of Arguments made by the Parties**

Both parties were present in the hearing. The contentions made by the parties are as follows:

### **Submission of the Complainant:**

- The complainant submitted that wrong billing from Aug'2019 to Jul'2024 served to him resulted to accumulation of arrear.
- He further submitted that he had made verbal complain to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

### **Reply Submission of the Respondent:**

- The respondent produced the billing abstract from Aug'2023 to Jul'2024.
- He had also produced a PVR dt.13.08.2024 mentioning the meter reading as "224" of meter number LW346080.
- The respondent also agreed to wrong billing from Aug'2019 to Jul'2024. However, the respondent requested the Forum to take appropriate decision as necessary.

## **Findings of the Forum**

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- During Jan'2024, a provisional bill of 6358 units had been served by the Respondent and the same is withdrawn in the next month.
- Another sundry of Rs.15,482.00 had been given during Mar'2024 and the cause is not explained or documentary evidence not produced by the Respondent.
- Therefore, it is decided by the Forum to drop the case.

### **Directions of the forum**

In view of the above findings and discussions, the Forum is of the view that,

- Due to non-availability of sufficient documents, the case is rejected.
