ORDER

Brief Facts of the Case

During the spot hearing at Sundargarh Electrical Section of Sundargarh Electrical Division camp on dt.14.08.2024, the complainant appeared before the Forum whereas SDO, Sundargarh, SED appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT-Domestic consumer with connected load of 01 Kw. That the Complainant has raised objection regarding provisional billing from Sep'2022 to Mar'2023. He requested for revision of bills and mentions about verbal complaint being made to the respondent earlier.

Gist of Arguments made by the Parties

Both parties were present in the hearing. The contentions made by the parties are as follows:

Submission of the Complainant:

- The complainant submitted that provisional billing from Sep'2022 to Mar'2023 served to him resulted to accumulation of arrear.
- He further submitted that he had made verbal complain to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

Reply Submission of the Respondent:

- The respondent produced the billing abstract from Jun'2022 to Jul'2024.
- He had also produced a PVR dt.13.08.2024 mentioning the meter reading as "474" of meter number TWSP51080192.
- The respondent also agreed to provisional billing from Sep'2022 to Mar'2023. However, the respondent requested the Forum to take appropriate decision as necessary.

Findings of the Forum

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- Provisional billing from Sep'2022 to Mar'2023 have been done with various units per month as the meter is defective.
- As per PVR submitted by respondent, a new meter bearing number TWSP51080192 had been installed in the premises of the complainant on dt.07.11.2023 and the current billing pattern is correct as the PVR.
- From the consumer ledger, it is clear that the Respondent had already revised the provisional bills and hence the case is to be dropped.

Directions of the forum

In view of the above findings and discussions, the Forum is of the view that,

- The provisional bills served to the complainant from Sep'2022 to Mar'2023 are to be revised by taking six months' average of actual consumption of new meter as per Section 155 and 157 of Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.
- Any adjustments done during the revision period are also to be taken into consideration.
- DPS charged on the wrong bills are also to be withdrawn.

Matter is closed herewith and the compliance report to be submitted to the undersigned on or before dated **30-09-2024**.

"If the complainant is aggrieved with this order or non-implementation of the order of the Grievance Redressal Forum in time, he/she can make the representation to the Ombudsman-II, Qrs. No. 3R-2(S), GRIDCO Colony, P.O: Bhoinagar, Bhubaneswar-751022 within 30 days from the date of order of the Grievances Redressal Forums".
