# **ORDER**

## **Brief Facts of the Case**

During the spot hearing at Sundargarh Electrical Section of Sundargarh Electrical Division camp on dt.14.08.2024, the complainant appeared before the Forum whereas SDO, Sundargarh, SED appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT-Domestic consumer with connected load of 01 Kw. That the Complainant has raised objection regarding average billing from Jan'2022 to Sep'2022. He requested for revision of bills and mentions about verbal complaint being made to the respondent earlier.

## **Gist of Arguments made by the Parties**

Both parties were present in the hearing. The contentions made by the parties are as follows:

### **Submission of the Complainant:**

- The complainant submitted that average billing from Jan'2022 to Sep'2022 served to him resulted to accumulation of arrear.
- He further submitted that he had made verbal complain to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

### **Reply Submission of the Respondent:**

- The respondent produced the billing abstract from Jan'2022 to Jun'2024.
- He had also produced a PVR dt.12.08.2024 mentioning the meter reading as "960" of meter number TWSP51078710.
- The respondent also agreed to average billing from Jan'2022 to Sep'2022. However, the respondent requested the Forum to take appropriate decision as necessary.

## **Findings of the Forum**

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- Average billing from Dec'2021 to Jan'2024 have been done with various units per month as the meter is defective. Wrong actual bill of 3180 units had been served in between this period also.
- As per PVR submitted by respondent, a new meter bearing number TWSP51078710 had been installed in the premises of the complainant on dt.15.11.2023 and the reading is 960 Kwh as on dt.12.08.2024.
- Therefore, it is decided by the Forum that, the provisional/wrong round billing period bills should be revised.


### **Directions of the forum**

In view of the above findings and discussions, the Forum is of the view that,

- The average bills served to the complainant from Feb'2022 to Jan'2024 (Two Years) are to be revised by taking six months' average of actual consumption of new meter as per Section 155 and 157 of Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.
- Any adjustments done during the revision period are also to be taken into consideration.
- DPS charged on the wrong bills are also to be withdrawn.

Matter is closed herewith and the compliance report to be submitted to the undersigned on or before dated **30-09-2024**.

*"If the complainant is aggrieved with this order or non-implementation of the order of the Grievance Redressal Forum in time, he/she can make the representation to the Ombudsman-II, Qrs.
