ORDER

Brief Facts of the Case

During the spot hearing at Bonai Electrical Section of Rourkela Sadar Electrical Division camp on dt.23.08.2024, the complainant appeared before the Forum whereas SDO, Bonai, RSED appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT-General Purpose consumer with connected load of 02 Kw. That the Complainant has raised an objection regarding wrong multiplying factor used in billing. He requested for revision of bills and mentions about verbal complaint being made to the respondent earlier.

Gist of Arguments made by the Parties

Both parties were present in the hearing. The contentions made by the parties are as follows:

Submission of the Complainant:

- The complainant submitted that wrong multiplying factor used in bills served to him resulted to accumulation of arrear.
- He further submitted that he had made verbal complain to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

Reply Submission of the Respondent:

- The respondent produced the billing abstract from Aug'2016 to Jul'2024.
- He had also produced a PVR dt.23.08.2024 mentioning the meter reading as "16549" of meter number WUS00543.
- The respondent also agreed to the wrong multiplying factor used in bills. However, the respondent requested the Forum to take appropriate decision as necessary.

Findings of the Forum

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- The bills from Aug'2016 to Aug'2022 have been billed on provisional basis. For the month of Sep'2022 bill has been served for "36906" units by recording the meter reading as "12302" Kwh. From Sep'2022 onwards almost actual bills have been served.
- The complainant avails single phase meter and single phase meter and MF of 3 is absolutely wrong. The Respondent is advised to change the MF to one.
- As per PVR submitted by respondent, a new meter bearing Sl. No. WUS00543 is installed on dt.23.02.2020 in the premises of the complainant and the current meter reading is "16549" Kwh as on dt.23.08.2024.
- Therefore, it is decided by the Forum that, the bills should be revised.

Directions of the forum

In view of the above findings and discussions, the Forum is of the view that,

- The bills served to the complainant from Sep'2022 to Jul'2024 are to be revised by taking MF as "01" as per Section 157 of Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.
- Any adjustments done during the revision period are also to be taken into consideration.
- DPS charged on the wrong bills are also to be withdrawn.

Matter is closed herewith and the compliance report to be submitted to the undersigned on or before dated **31-10-2024**.

"If the complainant is aggrieved with this order or non-implementation of the order of the Grievance Redressal Forum in time, he/she can make the representation to the Ombudsman-II, Qrs. No. 3R-2(S), GRIDCO Colony, P.O: Bhoinagar, Bhubaneswar-751022 within 30 days from the date of order of the Grievances Redressal Forums".
