# **ORDER**

## **Brief Facts of the Case**

During the spot hearing at Panposh Electrical Section camp on dt.17.08.2024, the complainant appeared before the Forum whereas SDO, Panposh, RSED appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT-Domestic consumer with connected load of 01 Kw. That the Complainant has raised objection regarding average bills from Sep'2023 to Nov'2023 served to him. He requested revision of bills and mentions about verbal complaint being made to the respondent earlier on.

## **Gist of Arguments made by the Parties**

Both parties were present in the hearing. The contentions made by the parties are as follows:

### **Submission of the Complainant:**

- The complainant submitted that average bills from Sep'2023 to Nov'2023 due to which high billings have been done resulted to accumulation of arrears.
- He further submitted that he had made verbal complaint to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

### **Reply Submission of the Respondent:**

- The respondent produced the billing abstract from Jan'2022 to Jun'2024.
- He had also produced a PVR dt.08.07.2024 mentioning the meter reading as "489" KWH of meter no. TW02091931.
- The respondent also agreed to the average bills from Sep'2023 to Nov'2023 and revision of bills. However, the respondent requested the Forum to take appropriate decision as necessary.

## **Findings of the Forum**

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- That the complainant has been billed on actual meter reading up to Aug'2023 with a meter reading of "2261" of meter No. 325134.
- The bills from Sep'2023 to Nov'2023 have been billed on average with various units per month. From Dec'2023 onwards almost actual bills have been served.
- As per PVR submitted by respondent, the new meter bearing Sl. No. TW02091931 have been installed on dt.08.12.2023 in the premises of the complainant and the meter reading is "489" Kwh as on dt.08.07.2024.
- Therefore, it is decided by the Forum that, the average period bills should be revised.

### **Directions of the forum**

In view of the above findings and discussions, the Forum is of the view that,

- The average bills served to the complainant from Sep'2023 to Nov'2023 are to be revised as per the average of six consecutive actual billing of new meter as per Section 155 and 157 of Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.
- Any adjustments done during the revision period are also to be taken into consideration.
- DPS charged on the wrong bills are also to be withdrawn.

Matter is closed herewith and the compliance report to be submitted to the undersigned on or before dated **31-10-2024**.

*"If the complainant is aggrieved with this order or non-implementation of the order of the Grievance Redressal Forum in time, he/she can make the representation to the Ombudsman-II, Qrs.
