ORDER

Brief Facts of the Case

During the spot hearing at Koelnagar Electrical Section of Rourkela Electrical Division camp on dt.20.08.2024, the complainant appeared before the Forum whereas SDO, Koelnagar, RED appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT-Domestic consumer with connected load of 0.5 Kw. That the Complainant has raised an objection regarding the abnormal billing from Sep'2012 to Oct'2020 served to him. He requested revision of bills and mentions about verbal complaint being made to the respondent earlier.

Gist of Arguments made by the Parties

Both parties were present in the hearing. The contentions made by the parties are as follows:

Submission of the Complainant:

- The complainant submitted abnormal billing from Sep'2012 to Oct'2020 served to him resulting to accumulation of arrears.
- He further submitted that he had made verbal complaint to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

Reply Submission of the Respondent:

- The respondent produced the billing abstract from AprJan'2020 to Jun'2024.
- He had also produced a PVR dt.23.07.2024 with status disconnected.
- The respondent also agreed to provisional billing from Sep'2012 to Oct'2020. However, the respondent requested the Forum to take appropriate decisions as necessary.

Findings of the Forum

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- That the complainant has been billed on actual meter reading upto Sep'2012 with a meter reading of "2030" of Meter No 718180.
- The bills from Oct'2012 to Oct'2020 had been billed on provisional basis @ 73 units per month. There after average bills started.
- The PVR submitted by respondent is not sufficient to withdraw the bills.
- Also it is not clear whether the complainant will avail supply in future or not.
- Therefore, it is decided by the Forum to reject the case.

Directions of the forum


In view of the above findings and discussions, the Forum is of the view that,

The case is dropped off.

The matter is closed herewith.

"If the complainant is aggrieved with this order or non-implementation of the order of the Grievance Redressal Forum in time, he/she can make the representation to the Ombudsman-II, Qrs. No. 3R-2(S), GRIDCO Colony, P.O: Bhoinagar, Bhubaneswar-751022 within 30 days from the date of order of the Grievances Redressal Forums".
