ORDER

Brief Facts of the Case

During the spot hearing at Bisra Electrical Section of Rourkela Electrical Division camp on dt.21.08.2024, the complainant appeared before the Forum whereas SDO, Bisra, RED appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT-General purpose consumer with connected load of 1.0 Kw. That the Complainant has raised an objection regarding the defective period of bill from Nov'2016 to Oct'2018 due to LD. He requested for revision of bills and mentions about verbal complaint being made to the respondent earlier.

Gist of Arguments made by the Parties

Both parties were present in the hearing. The contentions made by the parties are as follows:

Submission of the Complainant:

- The complainant submitted defective period of bill from Nov'2016 to Oct'2018 due to LD served to him resulted to accumulation of arrear.
- He further submitted that he had made verbal complain to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

Reply Submission of the Respondent:

- The respondent produced the billing abstract from Nov'2016 to Nov'2018.
- He had also produced a PVR dt.22.08.2024 mentioning the meter reading as "2604.05" of meter number TWSP51044265.
- The respondent also agreed to defective period of bill from Nov'2016 to Oct'2018 due to LD. However, the respondent requested the Forum to take appropriate decision as necessary.

Findings of the Forum

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- The bills from Nov'2016 to Oct'2018 has been billed on average basis @ 144 units per month though there was no power supply.
- As per PVR submitted by respondent, the new meter bearing meter number TWSP51044265 have been installed on dt.06.09.2023 in the premises of the complainant and the meter reading is "2604.05" Kwh as on dt.22.08.2024.
- Therefore, it is decided by the Forum that, the average bills should be withdrawn.

Directions of the forum

In view of the above findings and discussions, the Forum is of the view that,

- As there was no power supply from Nov'2016 to Oct'2018, all charges except fixed charges are to be withdrawn.

The matter is closed herewith and the compliance report to be submitted to the undersigned on or before dated **31-10-2024**.

"If the complainant is aggrieved with this order or non-implementation of the order of the Grievance Redressal Forum in time, he/she can make the representation to the Ombudsman-II, Qrs. No. 3R-2(S), GRIDCO Colony, P.O: Bhoinagar, Bhubaneswar-751022 within 30 days from the date of order of the Grievances Redressal Forums".
