ORDER

Brief Facts of the Case

During the spot hearing at Bonai Electrical Section of Rourkela Sadar Electrical Division camp on dt.23.08.2024, the complainant appeared before the Forum whereas SDO, Bonai, RSED appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT-Domestic consumer with connected load of 0.5 Kw. That the Complainant has raised objection regarding the provisional billing given from Feb'2023 to Jun'2024 served to him. He requested revision of bills and mentions verbal complaints being made to the respondent earlier.

Gist of Arguments made by the Parties

Both parties were present in the hearing. The contentions made by the parties are as follows:

Submission of the Complainant:

- The complainant submitted that provisional billing given from Feb'2023 to Jun'2024 served to him resulted in accumulation of arrears.
- He further submitted that he had made verbal complaint to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

Reply Submission of the Respondent:

- The respondent produced the billing abstract from Sep'2018 to Jul'2024.
- He had also produced a PVR dt.23.07.2024 mentioning the meter reading as "127" of meter number TWB659125.
- The respondent also agreed to the provisional billing given from Feb'2023 to Jun'2024. However, the respondent requested the Forum to take appropriate decision as necessary.

Findings of the Forum

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- That the complainant has been billed on actual meter reading up to Jan'2023 with a meter reading of "2151" of meter No. LW354275.
- The bills from Feb'2023 to Jun'2024 have been billed on provisional with various units per month. From Jul'2024 onwards actual bills have been served.
- As per PVR submitted by respondent, the new meter bearing Sl. No. TWB659125 have been installed in the premises of the complainant and the meter reading is "127" Kwh as on dt.17.08.2024.
- Therefore, it is decided by the Forum that the provisional bills should be revised.

Directions of the forum

In view of the above findings and discussions, the Forum is of the view that,

- The provisional bills served to the complainant from Feb'2023 to Jun'2024 are to be revised by taking average of six months' actual consumption of new meter as per Section 155 and 157 of the Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.
- Any adjustments made during the revision period are also to be taken into consideration.
- DPS charged on the wrong bills are also to be withdrawn.

The matter is closed herewith and the compliance report to be submitted to the undersigned on or before dated **31-10-2024**.

"If the complainant is aggrieved with this order or non-implementation of the order of the Grievance Redressal Forum in time, he/she can make the representation to the Ombudsman-II, Qrs. No. 3R-2(S), GRIDCO Colony, P.O: Bhoinagar, Bhubaneswar-751022 within 30 days from the date of order of the Grievances Redressal Forums".
