ORDER

Brief Facts of the Case

The present case has been registered in this forum vide Case No. 535 of 2024. The Complainant is a LT-Domestic consumer having consumer number 8114-2117-0351 with connected load of 01 Kw.

During hearing on dt.21-09-2024, the complainant did not appear before the Forum whereas SDO-IV, RED appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT-Domestic consumer having consumer No. 8114-2117-0351 with connected load of 01Kw. That the Complainant has raised objection regarding non-refunding of security deposit. He requested for revision of bills and mentions about verbal complaint being made to the respondent earlier on.

Gist of Arguments made by the Parties

The Respondent was present in the hearing. The contentions made by the party is as follows:

Submission of the Complainant:

• The complainant had not come to the hearing.

Reply Submission of the Respondent:

- The respondent produced one payment advice showing payment of Rs.2,565.33 to the Complainant on dt.18.09.2024.
- The respondent also agreed to non-payment earlier and now the amount has been refunded.
- However, the respondent requested the Forum to take appropriate decisions as necessary.

Findings of the Forum

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

 The Respondent refunded the security amount and it has been decided by the Forum to drop the case.

Directions of the forum

In view of the above findings and discussions, the Forum is of the view that,

• The case is dropped off.

The matter is closed herewith.
