ORDER

Brief Facts of the Case

During the spot hearing at Kalinga Vihar section of Rourkela Sadar Electrical Division camp on dt.05.09.2024, the complainant appeared before the Forum whereas SDO-I, RSED appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT-Domestic consumer with connected load of 01 Kw. That the Complainant has raised objection for wrong bill generated for the month of Jun'2024. He requested revision of bills and mentions about verbal complaint being made to the respondent earlier on.

Gist of Arguments made by the Parties

Both parties were present in the hearing. The contentions made by the parties are as follows:

Submission of the Complainant:

- The complainant submitted that wrong bill generated for the month of Jun'2024 due to which high billings have been done resulted to accumulation of arrears.
- He further submitted that he had made verbal complaint to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

Reply Submission of the Respondent:

- The respondent produced the billing abstract from Aug'2018 to Jul'2024 and a PVR dated 05-09-2024 mentioning the meter reading as "0001" of meter no. TWST1725310.
- The respondent also agreed to the wrong bill generated for the month of Jun'2024 and agreed for revision of bills. However, the respondent requested the Forum to take appropriate decision as necessary.

Findings of the Forum

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- That the complainant has cleared all dues on dt.26.07.2024 and took power supply after a long period of disconnection.
- A wrong bill of 1030 units has been generated for Jun'2024 though there is no power supply which the Respondent admits in his physical verification report.
- A new meter bearing Sl. No. TWST1725310 has been installed on dt.13.08.2024 in the premises of the complainant and the FMR is "001" Kwh as on dt.05.09.2024.
- Therefore, it is decided by the Forum that, the wrong bill generated during this period should be revised.

Directions of the forum

In view of the above findings and discussions, the Forum is of the view that,

- The wrong bill served to the complainant during Jun'2024 is to be withdrawn except fixed charges as per Section 157 of Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.
- Any adjustments made during the revision period are also to be taken into consideration.
- DPS charged on the wrong bills are also to be withdrawn.

The matter is closed herewith and the compliance report to be submitted to the undersigned on or before dated **31-10-2024**.

"If the complainant is aggrieved with this order or non-implementation of the order of the Grievance Redressal Forum in time, he/she can make the representation to the Ombudsman-II, Qrs. No. 3R-2(S), GRIDCO Colony, P.O: Bhoinagar, Bhubaneswar-751022 within 30 days from the date of order of the Grievances Redressal Forums".
