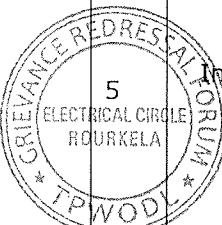

## **ORDER**

### **Brief Facts of the Case**

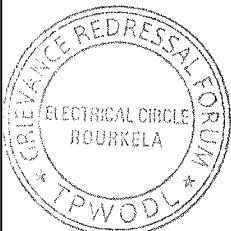
During the spot hearing at Ind. Estate Section Office of Rourkela Sadar Electrical Division camp on dt.25.10.2025, the complainant appeared before the Forum whereas SDO-I, RSED appeared as Respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is an LT-Domestic consumer having connected load of 1 KW. That the Complainant has raised objection for provisional billing from Mar'2021 to Jul'2022. He requested revision of bills and mentions about verbal complaints being made to the Respondent earlier on.

### **Gist of Arguments made by the Parties**

Both parties were present in the hearing. The contentions made by the parties are as follows:

#### **Submission of the Complainant:**



- The complainant submitted that provisional bills have been generated from Mar'2021 to Jul'2022 due to which high billings have been made resulting in accumulation of arrears.
- He further submitted that he had made verbal complaint to the Respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

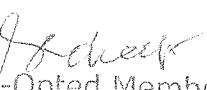
#### **Reply Submission of the Respondent:**

- The Respondent produced the following documents:
  - Billing abstract from Jan'2020 to Jul'2022.
  - Physical Verification Report on dt.24.10.2025.
  - Written version on dt.25.10.2025.
- The Respondent also agreed to the provisional billing from Mar'2021 to Jul'2022 and revision of bills.
- However, the Respondent requested the Forum to take appropriate decisions as necessary.

### **Findings of the Forum**

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- From Mar'2021 to Jul'2022, provisional bills have been served with various units per month as the meter is defective.
- The meter bearing Sl. No. TWST15134331 had been installed on dt.25.10.2025 and the current reading is 00 Kwh as on dt.25.10.2025.
- The concerned consumer's site has been in a disconnected state since Mar'2020. From the date of disconnection, there has been no power supply and no meter at site during this period. Despite this, bills continue to be generated from Mar'2020

to Jul'2022, as there was neither electrical connection nor a meter in place. These bills are not applicable. Therefore, the bills from entire period should be withdrawn.

- Therefore, it is decided by the Forum to revise the bills.

### **Directions of the forum**

In view of the above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations 155 and 157 of the Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.

- The bills served from Mar'2021 to Jul'2022 are to be revised by withdrawing all electricity charges except fixed charges.
- Any adjustments made during this period are also to be taken into consideration.
- DPS charged on the wrong bills are also to be withdrawn.
- The complainant must clear up all dues upon revision of bills.

The matter is close herewith.

The compliance report to be submitted on or before dt.**31.12.2025**.
