ORDER

Brief Facts of the Case

During the spot hearing at Bonai Electrical Sub-division of Rourkela Sadar Electrical Division camp on dt.18.09.2024, the complainant appeared before the Forum whereas SDO, Bonai, RSED appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT-Domestic consumer with connected load of 01 Kw. That the Complainant has raised objection regarding the average billing given from Mar'2022 to Oct'2023 served to him. He requested revision of bills and mentions verbal complaints being made to the respondent earlier.

Gist of Arguments made by the Parties

Both parties were present in the hearing. The contentions made by the parties are as follows:

Submission of the Complainant:

- The complainant submitted that average billing given from Mar'2022 to Oct'2023 served to him resulted in accumulation of arrears.
- He further submitted that he had made verbal complaint to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

Reply Submission of the Respondent:

- The respondent produced the billing abstract from Mar'2022 to Jul'2024.
- He had also produced a PVR dt.18.09.2024 mentioning the meter reading as "903" of meter number TW62068838.
- The respondent also agreed to the average billing given from Feb'2022 to Oct'2023. However, the respondent requested the Forum to take appropriate decisions as necessary.

Findings of the Forum

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- The bills from Mar'2022 to Oct'2023 have been billed on an average basis with various units per month. From Nov'2023 onwards almost actual bills have been served.
- As per PVR submitted by respondent, the new meter bearing Sl. No. TW62068838 has been installed in the premises of the complainant on dt.08.12.2023 and the meter reading is "903" Kwh as on dt.18.09.2024.
- Therefore, it is decided by the Forum to revise the provisional/average bills.

Directions of the forum

In view of the above findings and discussions, the Forum is of the view that,

- The average bills served to the complainant from Feb'2022 to Oct'2023 are to be revised by taking average of six months' actual consumption of new meter as per Regulation 155 and 157 of the Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.
- Any adjustments made during the revision period are also to be taken into consideration.
- DPS charged on the wrong bills are also to be withdrawn.


The matter is closed herewith and the compliance report to be submitted to the undersigned on or before dated **31-10-2024**.
