ORDER

Brief Facts of the Case

During the spot hearing at Ujalpur Electrical Sub-division of Sundargarh Electrical Division camp on dt.25.09.2024, the complainant appeared before the Forum whereas SDO, Ujalpur appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT-Domestic consumer with connected load of 0.5 Kw. That the Complainant has raised an objection regarding the provisional bills from Sep'2023 to Dec'2023 served to him. He requested revision of bills and mentions about verbal complaints being made to the respondent earlier on.

Gist of Arguments made by the Parties

Both parties were present in the hearing. The contentions made by the parties are as follows:

Submission of the Complainant:

- The complainant submitted that provisional bills from Sep'2023 to Dec'2023 served to him resulted in accumulation of arrears.
- He further submitted that he had made verbal complaint to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

Reply Submission of the Respondent:

- The respondent produced the billing abstract from Feb'2020 to Jul'2024.
- He had also produced a PVR dt.09.09.2024 mentioning the meter reading as "230" of meter number TWNX317475.
- The respondent also agreed to the provisional bills from Sep'2023 to Dec'2023 in his written version.
- However, the respondent requested the Forum to take appropriate decisions as necessary.

Findings of the Forum

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- That the complainant has been billed on actual meter reading up to Aug'2023 with a meter reading of "2435" of Meter WESCO9173286.
- The bills from Sep'2023 to Dec'2023 have been billed on provisional basis with various units per month.
- As per PVR submitted by the respondent, the new meter bearing Sl. No. TWNX317475 has been installed on dt.05.02.2024 in the premises of the complainant and the meter reading is "230" Kwh as on dt.09.09.2024. The first bill generated during Jan'2024 is a pro-rata bill and needs revision.
- Therefore, it is decided by the Forum that the provisional bills should be revised.

Directions of the forum


In view of the above findings and discussions, the Forum is of the view that,

- The provisional bills served to the complainant from Sep'2023 to Jan'2024 are to be revised by taking average of six months' actual consumption of new meter as per Section 155 and 157 of the Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.
- Any adjustments made during the revision period are also to be taken into consideration.
- DPS charged on the wrong bills are also to be withdrawn.

The matter is closed herewith.

The compliance report to be submitted to the undersigned on or before dt.31.10.2024.

"If the complainant is aggrieved with this order or non-implementation of the order of the Grievance Redressal Forum in time, he/she can make the representation to the Ombudsman-II, Qrs.
