# **ORDER**

## **Brief Facts of the Case**

During the spot hearing at Ujalpur Electrical Sub-division of Sundargarh Electrical Division camp on dt.25.09.2024, the complainant appeared before the Forum whereas SDO, Ujalpur appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT-Domestic consumer with connected load of 4.5 Kw. That the Complainant has raised an objection regarding the provisional/average bills from Oct'2020 to Dec'2023 served to him. He requested revision of bills and mentions about verbal complaints being made to the respondent earlier on.

## **Gist of Arguments made by the Parties**

Both parties were present in the hearing. The contentions made by the parties are as follows:

### **Submission of the Complainant:**

- The complainant submitted that provisional/average bills from Oct'2020 to Dec'2023 served to him resulted in accumulation of arrears.
- He further submitted that he had made verbal complaint to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

### **Reply Submission of the Respondent:**

- The respondent produced the billing abstract from Jan'2018 to Aug'2024.
- He had also produced a PVR dt.13.09.2024 mentioning the meter reading as "2208" of meter number TWB637874.
- The respondent also agreed to the provisional/average bills from Oct'2020 to Dec'2023 in his written version.
- However, the respondent requested the Forum to take appropriate decisions as necessary.

## **Findings of the Forum**

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- That the complainant has been billed on actual meter reading up to Sep'2020 with a meter reading of "12679" of Meter WCV05845.
- The bills from Oct'2020 to Dec'2023 have been billed on provisional basis with various units per month.
- As per PVR submitted by the respondent, the new meter bearing Sl. No. TWB637874 has been installed on dt.01.02.2024 in the premises of the complainant and the meter reading is "2208" Kwh as on dt.13.09.2024.
- Therefore, it is decided by the Forum that the provisional bills should be revised.

### **Directions of the forum**

In view of the above findings and discussions, the Forum is of the view that,

- The provisional/average bills served to the complainant from Jan'2022 to Dec'2023 (Two Years) are to be revised by taking average of six months' actual consumption of new meter as per Regulation 155 and 157 of the Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.
- Adjustments made during revision period are also to be taken into consideration.
- DPS charged on the wrong bills are also to be withdrawn.

The matter is closed herewith.

The compliance report to be submitted to the undersigned on or before dt.**31.10.2024**.
