ORDER

Brief Facts of the Case

During the spot hearing at Main Road Electrical Section of Rourkela Electrical Division camp on dt.15.10.2024, the complainant appeared before the Forum whereas SDO, Uditnagar, RED appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT-Domestic consumer with connected load of 01 Kw. That the Complainant has raised objection regarding at a time billing given during Sep'2021 served to him. He requested revision of bills and mentions verbal complaints being made to the respondent earlier.

Gist of Arguments made by the Parties

Both parties were present in the hearing. The contentions made by the parties are as follows:

Submission of the Complainant:

- The complainant submitted that at a time billing given during Sep'2021 served to him resulted to accumulation of arrears.
- He further submitted that he had made verbal complaint to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

Reply Submission of the Respondent:

- The respondent produced the billing abstract from Jan'2019 to Sep'2024.
- He had also produced a PVR dt.15.10.2024 mentioning the meter reading as "2686" of meter number WLT236878.
- The respondent also agreed to at a time billing given during Sep'2021 for 867 units.
- However, the respondent requested the Forum to take appropriate decisions as necessary.

Findings of the Forum

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- The bills from Jan'2019 to Sep'2021 have been billed on actual basis.
- During Sep'2021, at a time bill of 867 units had been served which is a suppress reading.
- Therefore, it is decided by the Forum that the actual bills should be spread up.

Directions of the forum

In view of the above findings and discussions, the Forum is of the view that,

- The average bills served to the complainant from Oct'2019 to Sep'2021 (Two Years) are to be revised by taking average of IMR "5293" (FMR of Sep'2019) and FMR "7056" (FMR of Sep'2021) as per Regulation 155 and 157 of the Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.
- Any adjustments made during the revision period are also to be taken into consideration.
- DPS charged on the wrong bills are also to be withdrawn.

The matter is closed herewith.

The compliance report to be submitted to the undersigned on or before dt.30.11.2024.

"If the complainant is aggrieved with this order or non-implementation of the order of the Grievance Redressal Forum in time, he/she can make the representation to the Ombudsman-II, Qrs. No. 3R-2(S), GRIDCO Colony, P.O: Bhoinagar, Bhubaneswar-751022 within 30 days from the date of order of the Grievances Redressal Forums".
