## **ORDER**

### **Brief Facts of the Case**

During the spot hearing at Rajgangpur Electrical Sub-Division of Rajgangpur Electrical Division camp on dt.21.10.2024, the complainant appeared before the Forum whereas SDO-II, Rajgangpur, RED appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT-Irrigation consumer with connected load of 03 Kw. That the Complainant has raised an objection regarding provisional/average billing from Feb'2019 to Jun'2023. He requested for revision of bills and mentions about verbal complaint being made to the respondent earlier.

### **Gist of Arguments made by the Parties**

Both parties were present at the hearing. The contentions made by the parties are as follows:

#### **Submission of the Complainant:**

- The complainant submitted that provisional/average billing from Feb'2019 to Jun'2023 served to him resulted in accumulation of arrears.
- He further submitted that he had made verbal complaint to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

#### **Reply Submission of the Respondent:**

- The respondent produced the billing abstract from Feb'2019 to Sep'2024.
- He had also produced a PVR dt.19.10.2024 of meter number 10046296 and meter reading as "1509" Kwh.
- The respondent also agreed to the provisional/average billing from Feb'2019 to Jun'2023.
- However, the respondent requested the Forum to take appropriate decisions as necessary.

## **Findings of the Forum**

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- The bills from Mar'2022 to Jun'2023 have been billed on provisional/average basis with various units per month.
- A new meter bearing serial number 10046296 had been installed during Oct'2023 and the CMR is "1509" Kwh as on dt.19.10.2024. The bill for Oct'2023 had been served on pro-rata basis and needs revision.
- Therefore, it is decided by the Forum that, the provisional/average billing period bills should be revised.

## **Directions of the forum**

In view of the above findings and discussions, the Forum is of the view that,

- The provisional/average bills served to the complainant from Mar'2022 to Oct'2023 are to be revised by taking six months' average of consumption of new meter as per Regulation 155 and 157 of the Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.
- Any adjustments made during the revision period are also to be taken into consideration.
- DPS charged on the wrong bills are also to be withdrawn.

The matter is closed herewith.
