ORDER

Brief Facts of the Case

During the spot hearing at Rajgangpur Electrical Sub-Division of Rajgangpur Electrical Division camp on dt.21.10.2024, the complainant appeared before the Forum whereas SDO-II, Rajgangpur, RED appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT-Domestic consumer with connected load of 01 Kw. That the Complainant has raised objection regarding the average billing given from Oct'2018 to Jun'2019 served to him. He requested revision of bills and mentions verbal complaints being made to the respondent earlier.

Gist of Arguments made by the Parties

Both parties were present at the hearing. The contentions made by the parties are as follows:

Submission of the Complainant:

- The complainant submitted that average billing given from Oct'2018 to Jun'2019 served to him resulted in accumulation of arrear.
- He further submitted that he had made verbal complaint to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

Reply Submission of the Respondent:

- The respondent produced the billing abstract from Sep'2018 to Sep'2024.
- He had also produced a PVR dt.17.10.2024 of meter number LW170653 and meter reading as "505" Kwh.
- The respondent also agreed to the average billing given from Oct'2018 to Jun'2019.
- However, the respondent requested the Forum to take appropriate decisions as necessary.

Findings of the Forum

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- The bills from Oct'2018 to Jun'2019 have been billed on an average basis with various units per month.
- A new meter bearing serial number LW170653 had been installed during Jul-Aug'2019 and the CMR is "505" Kwh as on dt.17.10.2024.
- Therefore, it is decided by the Forum that, the provisional/average billing period bills should be revised.

Directions of the forum

In view of the above findings and discussions, the Forum is of the view that,

- The provisional/average bills served to the complainant from Sep'2018 to Jun'2019 are to be revised by taking six months' average of consumption of new meter as per Regulation 155 and 157 of the Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.
- Any adjustments made during the revision period are also to be taken into consideration.
- DPS charged on the wrong bills are also to be withdrawn.

The matter is closed herewith.

"If the complainant is aggrieved with this order or non-implementation of the order of the Grievance Redressal Forum in time, he/she can make the representation to the Ombudsman-II, Qrs. No. 3R-2(S), GRIDCO Colony, P.O: Bhoinagar, Bhubaneswar-751022 within 30 days from the date of order of the Grievances Redressal Forums".
