ORDER

Brief Facts of the Case

During the spot hearing at Kalunga Electrical Sub-division of Rajgangpur Electrical Division camp on dt.28.10.2024, the Complainant appeared before the Forum whereas SDO, Kalunga, Rajgangpur Electrical Division appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT-General Purpose consumer with connected load of 01 Kw. That the Complainant has raised objection regarding average bills from Nov'2023 to Apr'2024 served to him. He requested bill revision and mentions verbal complaints being made to the respondent earlier on.

Gist of Arguments made by the Parties

Both parties were present in the hearing. The contentions made by the parties are as follows:

Submission of the Complainant:

- The complainant submitted average bills from Nov'2023 to Apr'2024 due to which high billings have been done resulting in accumulation of arrears.
- He further submitted that he had made verbal complaint to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

Reply Submission of the Respondent:

- The respondent produced the billing abstract from Oct'2010 to Sep'2024.
- He had also produced a PVR dt.28.10.2024 mentioning the meter reading as "338" Kwh of meter no. TBW329682.
- The respondent also agreed to the average bills from Nov'2023 to Apr'2024 and revision of bills.
- However, the respondent requested the Forum to take appropriate decisions as necessary.

Findings of the Forum

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- The bills from Nov'2023 to Feb'2024 have been billed on average basis with various units per month. From Mar'2024 onwards almost actual bills have been served.
- A new meter bearing Sl. No. TBW329682 has been installed on dt.28.04.2024 and the meter reading is "338" Kwh as on dt.28.10.2024. The bill served during Mar-Apr'2024 is a pro-rata bill and needs revision.
- It is decided by the Forum that the average period bills should be revised.

Directions of the forum

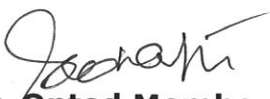
In view of the above findings and discussions, the Forum is of the view that,

- The provisional/average bills served to the complainant from Nov'2023 to Apr'2024 are to be revised as per the average of six consecutive billing of new meter as per Regulation 155 of the Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.
- Any adjustments made during the revision period are also to be taken into consideration.
- DPS charged on the wrong bills are also to be withdrawn.

The matter is closed herewith.
