# **ORDER**

## **Brief Facts of the Case**

During the spot hearing at Panposh section of Rourkela Sadar Electrical Division camp on dt.12.11.2024, the complainant appeared before the Forum whereas SDO-V, RSED appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT-PI consumer having Consumer Number 8140-0103-1209 with connected load of 2.5 Kw. That the Complainant has raised an objection for provisional/average billing from Jul'2021 to Jun'2023. He requested revision of bills and mentions about verbal complaints being made to the respondent earlier on.

## **Gist of Arguments made by the Parties**

Both parties were present in the hearing. The contentions made by the parties are as follows:

### **Submission of the Complainant:**

- The complainant submitted that provisional/average bills have been generated from Jul'2021 to Jun'2023 due to which high billings have been done resulted to accumulation of arrear.
- He further submitted that he had made verbal complaint to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

### **Reply Submission of the Respondent:**

- The respondent produced the billing abstract from Jul'2021 to Oct'2024 and a PVR dt.13.11.2024 mentioning the meter reading as "94" of meter no. 10035240.
- The respondent also agreed to the provisional/average billing from Jul'2021 to Jun'2023 and agreed for revision of bills.
- However, the respondent requested the Forum to take appropriate decisions as necessary.

## **Findings of the Forum**

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- From Jul'2021 to Jun'2023, provisional/average bills had been served with various units per month as the meter was defective.
- A new meter bearing Serial Number 10035240 had been installed on dt.25.07.2023 and meter reading is "94" as on dt.13.11.2024.
- Therefore, it is decided by the Forum to revise the provisional/average bills.

## **Directions of the forum**

In view of the above findings and discussions, the Forum is of the view that,

- The provisional/average bills served to the complainant from Jul'2021 to Jun'2023 (Two Years) are to be revised as per the average of six consecutive billing of new meter as per Section 155 and 157 of Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.
- Any adjustments made during the revision period are also to be taken into consideration.
- DPS charged on the wrong bills are also to be withdrawn.


The matter is closed herewith.
