ORDER

Brief Facts of the Case

During the spot hearing at Sundargarh Electrical Sub-division of Sundargarh Electrical Division camp on dt.20.11.2024, the complainant appeared before the Forum whereas SDO, Sundargarh, SED appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT-Domestic consumer with connected load of 03 Kw. That the Complainant has raised objection regarding the provisional bills from Jul'2023 and Feb'2024 served to him. He requested revision of bills and mentions verbal complaints being made to the respondent earlier.

Gist of Arguments made by the Parties

Both parties were present in the hearing. The contentions made by the parties are as follows:

Submission of the Complainant:

- The complainant submitted that provisional bills from Jul'2023 and Feb'2024 served to him resulted in accumulation of arrears.
- He further submitted that he had made verbal complaint to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

Reply Submission of the Respondent:

- The respondent produced the billing abstract from May'2022 to Oct'2024.
- He had also produced a PVR dt.11.11.2024 mentioning the meter reading as "562" of meter number TWSP51138615.
- The respondent also agreed to the provisional bills from Jul'2023 and Feb'2024.
- However, the respondent requested the Forum to take appropriate decisions as necessary.

Findings of the Forum

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- Provisional bills from Jul'2023 and Feb'2024 had been served with different units per month as the meter is defective.
- A new meter bearing Sl. No. TWSP51138615 has been installed on dt.05.04.2024 and the meter reading is "562" Kwh as on dt.11.11.2024. The first bill for the new meter is served on pro-rata basis and needs revision.
- From Mar'2024 onwards almost actual bills have been served.
- Therefore, it is decided by the Forum to revise the average bills.

Directions of the forum

In view of the above findings and discussions, the Forum is of the view that,

- The provisional/average bills served to the complainant from Jul'2023 and Mar'2024 are to be revised by taking average of six months' consumption of new meter as per Regulations 155 and 157 of the Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.
- Any adjustments made during the revision period are also to be taken into consideration.
- DPS charged on the wrong bills are also to be withdrawn.

The matter is closed herewith.

The compliance report to be submitted to the undersigned on or before dt.**31.12.2024**.

"If the complainant is aggrieved with this order or non-implementation of the order of the Grievance Redressal Forum in time, he/she can make the representation to the Ombudsman-II, Qrs. No. 3R-2(S), GRIDCO Colony, P.O: Bhoinagar, Bhubaneswar-751022 within 30 days from the date of order of the Grievances Redressal Forums".
