ORDER

Brief Facts of the Case

During the spot hearing at Bonai Sub-Division of Rourkela Sadar Electrical Division camp on dt.21.11.2024, the complainant appeared before the Forum whereas SDO-VII, RSED appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT-Domestic consumer having consumer No. 8147-1313-0248 with connected load of 01 Kw. That the Complainant has raised objection for provisional/average billing from Jul'2021 to Aug'2024 due to defective meter. He requested revision of bills and mentions about verbal complaints being made to the respondent earlier on.

Gist of Arguments made by the Parties

Both parties were present in the hearing. The contentions made by the parties are as follows:

Submission of the Complainant:

- The complainant submitted that provisional/average bills have been generated from Jul'2021 to Aug'2024 due to which high billings have been done resulting to accumulation of arrears.
- He further submitted that he had made verbal complaint to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

Reply Submission of the Respondent:

- The respondent produced the billing abstract from Mar'2021 to Oct'2024 and a PVR dt.20.11.2024 mentioning the meter reading as "330" of meter no. TWB134768.
- The respondent also agreed to the provisional/average billing from Jul'2021 to Aug'2024 and agreed for revision of bills.
- However, the respondent requested the Forum to take appropriate decisions as necessary.

Findings of the Forum

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- From Jul'2021 to Aug'2024, provisional/average bills have been served with various units per month as the meter is defective.
- A new meter bearing Serial Number TWB134768 has been installed on dt.23.09.2024 and the current reading is "330" Kwh as on dt.20.11.2024.
- During Sep'2024, bill has been served on pro-rata basis and needs revision.
- Therefore, it is decided by the Forum to revise the average bills generated.

Directions of the forum

In view of the above findings and discussions, the Forum is of the view that,

- The provisional/average bills served to the complainant from Oct'2022 to Sep'2024 (Two Years) are to be revised as per the average of six consecutive billing of new meter as per Regulations 155 and 157 of the Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.
- Any adjustments made during the revision period are also to be taken into consideration.
- DPS charged on the wrong bills are also to be withdrawn.

The matter is closed herewith.

The compliance report to be submitted to the undersigned on or before dt.**30.04.2025**.

"If the complainant is aggrieved with this order or non-implementation of the order of the Grievance Redressal Forum in time, he/she can make the representation to the Ombudsman-II, Qrs. No. 3R-2(S), GRIDCO Colony, P.O: Bhoinagar, Bhubaneswar-751022 within 30 days from the date of order of the Grievances Redressal Forums".
