ORDER

Brief Facts of the Case

During the spot hearing at Ujalpur Electrical Sub-division of Sundargarh Electrical Division camp on dt.29.11.2024, the complainant appeared before the Forum whereas SDO, Ujalpur appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT-General Purpose consumer with connected load of 2.5 Kw. That the Complainant has raised an objection regarding the wrong delayed payment surcharge from Nov'2021 to Apr'2023 served to him. He requested revision of bills and mentions verbal complaints being made to the respondent earlier.

Gist of Arguments made by the Parties

Both parties were present at the hearing. The contentions made by the parties are as follows:

Submission of the Complainant:

- The complainant submitted the wrong delayed payment surcharge from Nov'2021 to Apr'2023 served to him resulted in accumulation of arrears.
- He further submitted that he had made verbal complaint to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

Reply Submission of the Respondent:

- The respondent produced the following documents:
 - Billing abstract from Nov'2021 to Oct'2024.
 - Physical Verification Report on dt.29.11.2024.
 - Written version on dt.29.11.2024.
- The respondent also agreed to wrong delayed payment surcharge from Nov'2021 to Apr'2023 and revision of bills.
- However, the respondent requested the Forum to take appropriate decisions as necessary.

Findings of the Forum

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- DPS of Rs.110.00 and Rs.658.00 had been charged during Jan'2022 and Nov'2022 respectively. As the provisional bill of Jan'2022 had been withdrawn later, the DPS must be withdrawn. The DPS charged during Nov'2022 is very high and no logic found in calculation.
- Therefore, it is decided by the Forum to withdraw the DPS from bills.

Directions of the forum

In view of the above findings and discussions, the Forum is of the view that,

- The DPS charged during Jan'2022 and Nov'2022 are to be withdrawn as per Regulations 155 and 157 of the Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.
- Any adjustments made during the revision period are also to be taken into consideration.
- DPS charged on the wrong bills are also to be withdrawn.

The matter is closed herewith.
