ORDER

Brief Facts of the Case

During the spot hearing at Rajgangpur-II Electrical Sub-division camp on dt.20.12.2024, the complainant appeared before the Forum whereas SDO Electrical, Rajgangpur-I appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is an LT-LI consumer having connected load of 03 KW. That the Complainant has raised objection for average billing from Jun'2014 to Nov'2024. He requested for revision of bills and mentions about verbal complaint being made to the respondent earlier on.

Gist of Arguments made by the Parties

Both parties were present in the hearing. The contentions made by the parties are as follows:

Submission of the Complainant:

- The complainant submitted that average bills have been generated from Jun'2014 to Nov'2024 due to which high billings have been done resulted to accumulation of arrears.
- He further submitted that he had made verbal complain to the respondent about the erroneous bill.
- He also requested the Forum to revise the bills.

Reply Submission of the Respondent:

- The respondent produced the following documents:
 - Billing abstract from Jun'2014 to Oct'2024.
 - Physical Verification Report on dt.17.12.2024.
 - Written version on dt.20.12.2024.
- The respondent also agreed to the wrong billing from Jun'2014 to Nov'2024 and revision of bills.
- However, the respondent requested the Forum to take appropriate decisions as necessary.

Findings of the Forum

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents and provisions of law have concluded as follows:

- From Jun'2014 to Nov'2024, provisional bills have been served mostly with various units per month as the meter reading are properly not taken. Latter provisional bills had been withdrawn properly.
- A new meter bearing Sl. No. TWSC59004563 has been installed on dt.02.02.2024 and the current reading is 338 Kwh as on dt.17.12.2024.
- Therefore, it is decided by the Forum to reject the case as nothing to revise


Directions of the forum
